
Sub:- Tentative Seniority List of OS-II under Ajmer Discom as on 01.04.2014

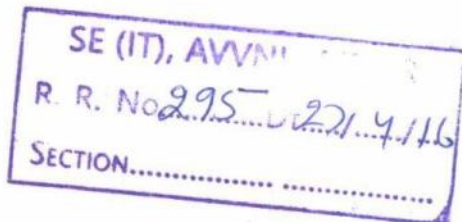


