In case of any discrepancy found in bidding documents downloaded from the website and appended with the bid (as a bid document) and original copy of such document available in the office of Superintending Engineer (MM), Ajmer Discom, Ajmer then the copy available with Superintending Engineer (MM), Ajmer Discom, Ajmer will be considered as final document for all purpose. The cost of Bid document as published in NIT shall be furnished along with EMD one day prior to opening of bid i.e. and scane copy be upload on website of RISL downloaded bid document in the manner prescribed in bid document.

SECTION-III

TECHNICAL SPECIFICATIONS FOR SUPPLY OF EHV GRADE TRANSFORMER OIL AGAINST TN-1116

3.01 This specification covers manufacture, testing, inspection, supply and delivery of fresh, unused and pure EHV grade insulating transformer oil. The transformer oil should be clear and transparent and free from moisture and other suspended matter which are likely to impair its properties and without any additive including oxidation inhibitor.

3.02 **QUANTITY**:

Transformer Oil - 2600 KL

The quantity as indicated above is approximate and may be increased or decreased to any extent at the time of finalisation of this tender enquiry.

3.03 **SPECIFICATION OF TRANSFORMER OIL**:

The transformer oil is for insulation and cooling of the electric transformers and switchgears of extra high voltage conforming to the Technical particulars as available at Appendix-I. The oil should also be suitable for oil circuit breakers and other electrical equipments in which oil is used as insulating medium. The tests on transformer oil shall be conducted in accordance with the relevant methods detailed in IS:335/1993 as amended up to date and as per our specification.

The input materials for the manufacture of transformer oil viz transformer oil base stock/ transformer oil feed stock shall be from Lube Refineries of Indian Oil Corporation/ Hindustan Petroleum Corporation/ Madras Refineries or may be imported and such TOBS/ TOFS shall have viscosity of 50 Redwood second or more at 37.8 deg.c. The supplier shall furnish the relevant documents in token of purchase of TOBS/ TOFS from the Lube Refineries or bill of landing/ entry (for imported TOBS) before effecting the supplies.

The technical parameters of the transformer oil are available at Appendix-I.

3.04 **PACKING**:

Packing shall be done in brand new barrels on non returnable basis, generally conforming to IS-1783 (Part-I)/1993: Grade A Type-2, 200/210 litre nominal capacity barrels made from 1.25 mm nominal thickness CRCA steel sheets. Body provided with two extended rolling hoops. Finished with one coat of stowing general paint on the outside.

Both the bungs big and another small shall be provided with capsules over screw caps and provisions shall be made on the upper part of the drum in such a way that capsule can provide a seal between the drum and its concerns.

There will in addition be a provision on the capsule to apply numbered polycarbonate seal with identification mark on the upper part of the drum in such a way that capsule can provide a seal between the drum and its corners.

There will in addition be a provision on the capsule to apply numbered polycarbonate seal with identification mark by the seals representative of purchaser in such a way that it would be impossible to tear the capsule without destroying the purchasers polycarbonates seals of identification mark.

3.05 **Markings:**

Each barrel/drum shall be indelibly marked with the following:

- a) Manufacturer's name or trade mark.
- b) Quantity in litres.
- c) Transformer oil.
- d) The word "Low Viscosity Type".
- e) Identification in code or otherwise to enable the date and lots of manufacture to be traced back to the factory records.
- f) ISI Certification Mark.
- g) Ajmer Vidyut Vitran Nigam Limited, Ajmer
- h) Consignees name.
- i) Sr.No. of Drum

The ISI mark on each Drum body shall be provided invariable.

The above marking shall be done with such type of ink which is customarily employed/approved in petroleum products.

3.06 **TEST CERTIFICATE**:

The transformer oil shall invariably bear ISI certification mark for which ISI registration number shall be clearly indicated. The test certificate obtained from a recognised independent testing laboratory for transformer oil as per the IS 335/1993 with latest amendments shall be furnished along with the tender offer failing which the offer is liable to be rejected. The test certificate shall not be more than one year old. The values obtained shall not be inferior to those specified at Appendix-1 of the specification.

3.07 **INSPECTION, CHECKING & TESTING**:

Inspection, checking and testing as per IS 335/1993 (with latest amendments) and as per GTP of the purchase order of transformer oil shall be carried out before despatch.

The tests for electrical characteristics shall be conducted at the manufacturers works in the presence of our Inspecting Officer. Our inspecting officer will also provide numbered polycarbonate/Lead seal on each drum with identification for convenience of our field staff.

3.08 STORE CHECKING

- i) Composite samples from each lot shall be drawn from Nigam's Store in presence of firm's representative and will be sent for complete testing at CPRI, Bangalore. The testing of composite sample will also be carried out as per GTP of the Purchase Order. The firm will provide all facilities for drawing composite sample and hence presence of firm's representative for drawing sample will be mandatory. In case the sample of oil drum fails in type test at CPRI, Bangalore then for the used material, payment will be released after 15% deduction and remaining material will be lifted back by the firm. Necessary Payment will be released only after selection of Composite sample and store checking. The volume measurement at CTL shall be corrected to 29.5 °c.
- ii) All charges for testing at CPRI Bangalore shall be borne by the supplier. Sampling of the oil for testing will be done in accordance with IS 6855/1972 (amended upto date).
- iii) One out of every 100 drums or part thereof from each lot (i.e. quantity received in Store(s) after inspection) will be selected for verifying tare weight of drum, total weight of drum and quantity in liters & compared with the packing details provided in the inspection report/ drum. The highest variation in percentage on negative side in respect of volume (in Liters) in CTL checking will be applicable on the sub-lot (storewise) for release of payment. However, volume (in Litres) will not be considered more than the capacity of drum, for release of payment.
- iv) The work of composite samples selection from each lot shall be carried out at CTL Ajmer in presence of firm's representative and samples will be sent for complete testing at CPRI, Bangalore by this office.
- v) The XEn (CTL) will intimate the scheduled date to the firm for quantity verification and drawing of composite sample.

3.09 **PRICE VARIATION**:

The variation in quoted price of transformer oil shall be as per Annexure-II. The base price will be one month prior to the opening of the techno-commercial bid of the tender.

3.10 The quantity on order can be supplied with plus/ minus half percent tolerance.

3.11 PAYMENT IN ABSENCE OF TYPE TEST REPORTS

The provision of 85% payment in absence of type test reports will be applicable only for the old manufacturers who have supplied this item to any of the State Electricity Board/ Utility and the same have been type tested as per provisions of relevant ISS.

3.12 **Delivery**

The bidder is required to quote monthly delivery. The delivery of quoted quantity should be completed in Eight months (at equal monthly rate) period after commencement period of 60 Days (Max.). In case ordered quantity is different than quoted quantity then monthly delivery shall be adjusted proportionately.

Material Price Variation Clause for Transformer Oil.

The price quoted/ confirmed is based on the cost of raw materials/ components as on the date of quotation and the same is deemed to be related to price of TOBS and drum as specified in price variation clause given below. In case of any variation in these prices, the price payable shall be subject to adjustment up or down in accordance with the following formula with base date as on (01.01.2017):

P = Po + 1.2 (TB - TBo) + 4.8(D - Do)

Wherein:-

P = Price (In Rs./KL) payable as adjusted in accordance with the above formula.

Po = Price (In Rs./KL) quoted/ confirmed for transformer oil supplied in drums and confirming to IS:335/1993 and amended from time to time.

TBo= CIF price of TOBS (refer notes)

This price is applicable on first working day of the month. One month prior to date of tendering).

Do = Price of drums (refer Notes)

(This price is applicable on first working day of the month. One month prior to date of tendering).

For example, if the date of tendering falls in March, 2013 the applicable prices of TOBS (Tbo) and drums (Do) should be prevailing as on 01.02.2013.

The above prices are as published by IEEMA vide circular reference number IEEMA (PVC) TR-OIL prevailing as on first working day of the month 01.03.2013 i.e. one month prior to the date of tendering.

TB = CIF price of TOBS (Refer Notes).

This price is applicable on first working day of the month. One month prior to date of delivery.

D = Price of drums (Refer Notes).

This price is applicable on first working day of the month. One month prior to date of delivery.

For example, if the date of delivery in terms of clause given below falls in December, 2013 the applicable price for TOBS (TB) and drum (D) should be as published by IEEMA as prevailing on 01.11.2013.

The "Date of delivery is the date on which the transformer oil is notified as being ready for inspection despatch. (In the absence of such notification the date of receipt of manufacturer's inspection offer in this case shall be considered as the date of delivery) or the contracted delivery date (including any agreed extension thereto) whichever is less. Normally material ahead of delivery shall

not be accepted. However, in case same is accepted on requirement of purchaser. The price variation applicable for such be payable.

NOTES:

- A) All prices of raw material are exclusive of modvatable excise CV duty amount and exclusive of any other Central, State or local taxes, octroi etc.
- B) All prices are as on first working day of the month.
- C) The details of prices are as under:
- 1. The price of TOBS (in Rs./KL) considered in the CIF price for Group-II 70 grade oil as published in ICTS-LOR bulletin for the first week of the previous month. This price is normally published in US dollars per gallon which is converted in Rs./KL by IEEMA using multiplying factor and the customs exchange rate prevailing on first working day of the previous month. This price is inclusive of import duty prevailing as on the first working day of previous month but exclusive of modvatable CVD and other taxes.
- 2. The price of drum (in Rs.) is the ex-works price as quoted by a drum manufacturer for drum of capacity of 210 litres.

SCHEDULE-III-A

PRE QUALIFICATION REQUIREMENT (PQR) ITEM: - EHV GRADE TRANSFORMER OIL TN-1116

The Bidder should fulfil following qualification requirements for successful participating in the tender. The bids without relevant documentary evidence in support of each qualifying requirement shall be considered non responsive & rejected.

1. STATUS OF BIDDER

- a) The bidder should be manufacturer of offered items (TRANSFORMER OIL). The offers from sole selling agent/authorized dealers shall not be entertained.
- b) Old/new suppliers:- Any bidder having their works located within or outside the state of Rajasthan has albeit participated for the first time in a particular Discom and meeting minimum qualification requirement (whether Raj. Or outside Rajasthan) has supplied the tendered material/higher rating in other utility shall be treated as an old supplier. Rajasthan based firms not meeting minimum quantity supplied criterion but having manufacturing and adequate testing facility and technical know how shall be considered as new firms and would be eligible for trial order only.

2. PAST SUPPLY AND PERFORMANCE CRITERIA

The bidder shall meet both past supply and performance criteria as detailed below for opening of tenders.

2.01. PAST SUPPLY:-

- 2.01.1 The bidder is required to quote for minimum 10% of tendered quantity, failing which the offer may be considered non responsive.
- 2.01.2 The bidder should have designed, manufactured / fabricated, tested and supplied to utility / Discoms / Govt. Departments at least 2 X QQ (QQ being the quoted quantity) of similar item / higher rating of tendered material / equipment in last 3 financial years from the date of opening of technical-commercial bid.
- **Note:** Requirement of quantity manufactured, minimum quantity to be offered and amount of Bank Guarantee to be furnished in absence of test certificate shall be reduced to 25% for Rajasthan based units.
- 2.01.3 In support of fulfillment of the past supply criteria, the bidder shall furnish documentary evidence in the form of certificate from Chartered Accountant in the enclosed prescribed proforma only. This prescribed proforma should be furnished either in original or copy duly attested by Notary. The bidder shall also sign and affix seal on the C.A. Certificate. The certificate should have membership number with the name & address of the chartered accountant. Certificate should clearly indicate the quantity supplied, period of supply, voltage Class, Rating of the Transformer etc. in the format prescribed, any deviation to format or information diverted format, will not be considered and rejected.

Note:-The material supplied and accepted for same/higher rating for Turnkey projects to a licensed power utility/Govt. shall be considered for the purpose of evaluating criteria. The certificate given by C.A. shall indicate above quantity separately.

2.02 PERFORMANCE CRITERIA:-

- 2.02.1 i) If a bidder has supplied up to 50% of ordered quantity in previous tender up to date of opening of subsequent tender and scheduled delivery period expired, the bid of such bidder will not be opened in the Discom for that item.
 - ii) However, if the supplies have been completed for a quantity more than 50% but not completed up to date of opening of subsequent tender and scheduled delivery period expired, the quantity equal to the quantity pending in previous tender for that item shall be reduced from the subsequent tender quantity to be allocated to the bidder.

3.00 TYPE TEST CRITERIA:-

- 3.01 The bidder shall furnish valid and authenticated type test certificates from a Govt. approved / Govt. recognized / NABL Accredited laboratory / ILAC i.e. International Laboratory Accredited Laboratory (in case of foreign laboratory) of similar rating and design of tendered material/ equipment. Such type test certificates should not be older than 5 years as on the date of bid opening. For this purpose date of conducting type test will be considered.

- 3.03 The type test certificates shall be furnished either in original or copy duly attested by notary.
- 3.04 The bids of only those bidders shall be considered to be meeting the type test criteria who furnishes complete type test certificate with the bid as per above provision.

 However, in the following cases the bid of the bidder may be considered meeting the type test criteria if the bidder furnishes an undertaking stating that valid type test certificate from a Govt. / Govt. approved / Govt. recognized / NABL accredited / ILAC accredited laboratory shall be furnished from first lot (without asking any delivery extension) along with bank guarantee with the technical bid from a Nationalized / Scheduled Bank in prescribed proforma at Schedule-III C or DD/ Pay Order amounting to Rs.5 Lac / Rs.1.5 Lac / Rs.0.5 Lac in case where the value of the purchase (corresponding to tendered quantity) under consideration is more than 1.5 Crore / upto 1.5 Crore/ Upto 0.5 Crore respectively. The initial validity of Bank Guarantee shall be nine months with claim period of three months in addition.
- i) A new Rajasthan based unit who does not possess valid type tests reports subject to technically competent.
- ii) Where one or more type tests) is/ are older than 5 years.
- iii) Where new type tests have been added in the specification.
- iv) Where some changes in respect of type test procedure of existing type tests have been introduced in the relevant standard.
- v) Where a new item is being purchased by Nigam for the first time.
- vi) The Rajasthan & outside Rajasthan firm who does not possess valid type tests certificates, if type test reports of higher rating are furnished

4.0 POOR RECORD OF PERFORMANCE AND DELIVERY:

The bidder who has been black listed in any of the state Discom or with whom business relations have been severed in Ajmer Discom shall not be considered. Severment of business relations will be done in case of following circumstances for the period and with the recovery mentioned against each:

5.0 (A) BLACK LISTING OF A FIRM:

After having given Show Cause Notice of 30 days, and having established & cogent reasons for blacklisting of the firm as given below, the firm should immediately be blacklisted for a period of 5 years indicating reasons of doing so, in the letter itself, and a copy of such blacklisting should be given to the firm, with the approval of CLPC:-

- (i) There are sufficient and strong reasons to believe that the supplier or his employee has been guilty of malpractices such as manhandling/misbehaviour with Government official by supplier or his partner/employee, bribery, corruption or abatement of such a offence in a position where he could corrupt Nigam's official, fraud, vitiating fair tender process including substitution of or interpolation in tender, mis-representation, pilfer-aging or unauthorized use or disposal of Nigam's material issued for specific work etc.
- (ii) Where a supplier or his partner or his representative has been convicted by a court of Law for offences involving moral turpitude in relation to the business dealing or where security considerations including suspected disloyalty to the Nigam/state so warrant the blacklisting.
- (iii) If the State Bureau of Investigation or any other authorized investigating agency recommends for blacklisting after completing the investigation.
- Note: 1 If a supplier after having tendered for a supply or after negotiations gives application voluntarily vitiating the fair tendering process; it shall also tantamount to malpractice.
- Note:-2 A register containing the reasons for blacklisting the supplier as also the names of all the partner of the suppliers and the allied concerns coming within the effective influence of the blacklisted supplier will be maintained.
- Note: 3 A register of black listed supplier will be maintained which will not only include suppliers enlisted with the Enlisting Authority but also black listed suppliers in Nigam.
- Note :-4 A Black listed supplier (i) shall not be entitled for registration in any of the Discom (ii) shall not be awarded any supply order in future in any Discom during the notified period.(iii) his registration if any shall stand cancelled immediately and his registration security /EMD/S.D. shall stand forfeited. (iv) In case of blacklisting of the firm by any one of Discom for the cogent prescribed reason(s) as stipulated above, the same shall be applicable to all the three Discoms and as a

consequence of blacklisting, all the pending orders to that firm, will be cancelled in all three (3) Discoms with immediate effect. However in respect of completed/executed contract G.P. obligations as well as other liabilities shall be fulfilled by the supplier.

(B) SEVERMENT OF BUSINESS RELATION:

- (a) After having given Show Cause Notice of 30 days, and having established & cogent reasons for Severment of business relation as given below, the firm should immediately be severed the business relations for a period of 2 to 3 years indicating reasons of doing so, in the letter itself, and a copy of such severment should be given to the firm, with the approval of CLPC:-
- (i) The supplier continuously refuses to pay Nigam dues without showing adequate reasons and where the purchasing authority is satisfied that no reasonable dispute attracting reference to Settlement Committee or Court of Law exists for the supplier's action of non-supply.
- (ii) When vendor does not accept LOI/detailed purchase order awarded on its accepted prices and terms & conditions or does not comply with the contractual formalities.
- (iii) When vendor/supplier who otherwise completed contractual formalities but does not commence supplies on the date of opening of technical bid of the fresh tender/completion of schedule delivery period whichever is later.
- **Note-1**. In case supplier does not deposit outstanding dues towards Nigam, even after completion of severment period, the period of severment will continue.
 - 2. Severment done purely/ mainly on account of non-deposition of dues against the supplier/vendor/contractor could be lifted by CLPC, if the dues are deposited prior to the expiry of such severment period.
 - 3. Severment done by one Discom for non-supply of material and /or corresponding non-recovery of dues will not be effective in other Discoms except in respect of common purchase cases of three Discom.
 - **4**. On severment of business, the EMD/SD/vendor registration security will be forfeited.
 - **5.** The orders in execution satisfactorily will not be cancelled other than the order on which severment have been done.

(C) DEBARMENT

Reasons on which Debarment can be made:-

- (i) The competent authority may debar the supplier on account of his performance or other disabilities, if it is no longer considered fit to remain under vendor registration as per his obligation under vendor registration.
- (ii) If at any subsequent stage of inspection of firms after award of contract, it is found that firm does not have sufficient tech. staff or required/necessary technical equipments, the purchasing authority can debar the firm for one year or next tenders whichever is later. The debarment will be lifted only on re-inspection of firm's works; the defects noticed earlier are fully rectified to the satisfaction of Nigam.

6.0 APPEALS AND APPLICATIONS:-

Appeal against the order of blacklisting, severment and debarment can be filed before BOD within a period of 3 months from the date of intimation. The letter of appeal will be addressed to the order placing authority. Who will process the case for placing the matter in B.O.D. with in a period 60 days. The BOD may reduce or waive the penalty, if sufficient reasons/supporting documents are furnished by the supplier.

- 5. The bids not accompanied with qualification requirement, technical requirement indicated in the specification and other requirement given here under will be considered as incomplete offer and sufficient grounds for offer to be passed over:
 - i) Capacity, capability and competency proofing documents.
- a) Capacity /orders of similar and higher rating of tendered equipment booked as on date of biding with type and rating and construction details of equipment for which order received be indicated.
- b) Copy of purchase orders of Erstwhile RSEB /SEB`S / Electric Utilities / Govt. Departments / Discoms for similar or higher rating equipment latest executed.
 - ii) Year wise past experience for last 5 years of similar or higher rating of tendered equipment.
 - iii) The details of testing facilities available at the works and copies of latest type test certificates, carried out on similar ITEM.
 - iv) Quality assurance plan.
 - v) Complete guaranteed technical particulars, out lines and general arrangement drawings along with Bill of Material.
