1. Execute T-code-PA70
2. Select start date as 01.03.2019 and end date as 31.03.2019
3. Select Info type-Additional Payment/Deductions
4. Select Subtype- 9003 and Create.
5. In next screen fill up employee codes and their respective total amount of medical reimbursement and conveyance allowance and SAVE

Execute the payroll and check F16 PART B (Annexure) through T-code-PC00\_40\_F16.

In continuation of this memo no NO.RVPN/CAO/Sr.Ao (Ea-Cash)/D.1345 dated 11.10.18, it is to intimate that while submitting the tax calculation for the A.Y.2019-20 following Income-Tax amendments are to be considered:-

- The Tax Exemption on medical reimbursement up to Rs.15000/- available u/s 17(2) of Income Tax act 1961 has been deleted/removed w.e.f. A.Y.2019-20.
- The Tax Exemption on conveyance allowance has been deleted/removed w.e.f. A.Y.2019-20. Kindly add the compensatory (Conveyance) allowance in the Income
