


• TERMS & CONDITIONS

- Jeep/Bolero/Car with taxi permit (Essentially of Rajasthan State) is to be provided with driver without POL.
- Minimum average required is 12 Kms /Ltr. In case of jeep/Bolero.
- The POL will be provided by the department as per average of 12 Kms/Ltr. In case of Jeep/Bolero. If the average is found less than 12 Km/Ltr (Jeep/Bolero) and then the difference of the cost of the diesel / Petrol will be recovered from the bills of the vehicle provider
- One ltr. Engine Oil will be provided by the department for every 1000 Kms running of the vehicle (Jeep/Bolero)
- Working hours of the vehicle will be 24 Hrs. as per requirement.
- The vehicle provided by the contractor will be maintained by him in good and perfect condition.
- Security deposit: - in order to secure / assume the fulfillments of the terms & conditions this order the contractor shall deposit the security amount equivalent to 2% (Two Percent) of the ordered value of the work awarded. In case to the account officer RVPN or the same will be recovered running bill of the vehicle provider. The security deposit shall be refunded after two months of the successful completion of the contract to the entire satisfaction of the Nigam.
- The rate shall be inclusive of all taxes except service tax applicable which will be paid extra.
- The toll tax if any, during ply of the vehicle as per instructions of in charge of the vehicle, will be paid by the department.
- In the event of any bridge of any terms & condition or delay or default the contract will be terminated and security deposits and other financial holds will be forfeited by the nigam . No interest shall be paid on such deposits.
- All expenditure on repair, Maintenance, Taxes, permits, insurance & driver will be borne by the contractor

• SPECIFICATIONS OF THE VEHICLE :-

- The vehicle should have valid certificate of "Pollution under control"
- The vehicle should have "valid insurance coverage" and up to date road tax paid documents.
- The Milometer of the vehicle must be accurate and in working conditions at all times.
- Photostat copy of registration certificate, Taxi permit, Fitness certificate, Insurance, Road Tax, Pollution under control etc. for vehicle provided shall be submitted with the offered rate/Quotations.
- The vehicle must ply on all those roads / cart tracks, which are considered suitable by the in charge of the vehicle and his decision in this regard shall be final & binding.

- All the documents of the vehicle must be renewed time to time before its expiry of validity, during the contract period.
- The vehicle should not be more than five years old.
- DRIVER:-
- Contractor has to provide driver with said vehicle at his cost.
- Driver must have valid driving license (Commercial) for the entire period of the contract and the photocopy and original for verification shall be submitted at the time of agreement.
- Full particulars of the drivers are to be given by you at the time of agreements
- Driver should be well dressed and well behaved. Any misbehavior by the driver shall be considered unsatisfactory services.
- Driver must not smock or drink liquor while on duty and must not be under intoxication while of duty.
- Driver shall have sufficient money with him so that he can meet the expenditure on any incidental repairs /Maintenance etc. during working hrs. When the vehicle is on duty. The Nigam under no circumstances will incur any expenditure on these items.
- A log Book for each vehicle will be maintained by the driver in the format decided by the Vehicle In charge for recording daily opening and closing kilometer reading of each Journey performed and get signature of the user of the vehicle.




