8. If any charges of Toll Tax will be borne by the Nigam on production of valid receipt.
9. The vehicle should not be more than 6 Yrs. Old.
10. The payment Shall be arranged on monthly basis by the A.O. (T&C), RRVPNL, Hanumangarh against the verified bill by this office, through RTGS/NEFT, after statutory deduction if any.
