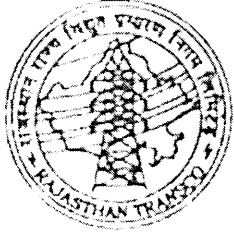

**The rates as per this circular are as follows :-**

1. For first 1500Kms or less, 20,000/- per month ( applicable taxes extra).
2. For additional running of vehicle (more than 1500Kms) the rate payable @ Rs. 7.25 per Km.
3. Hired vehicles shall be used anywhere as per jurisdiction of the office where deployed. In case of night halt other than that of head quarter a sum of Rs. 200 per night shall be paid for the driver.
4. The maximum ceiling of Rs. 23625/- per month (service tax extra if applicable) for 2000Kms for offices having a district as their jurisdiction.
5. All taxes except toll tax shall be borne by the individual/contractor/firm.
6. Reimbursement of toll tax paid by the individual/ contractor/ firm shall be made on production of receipt of payment of toll tax.

**Other conditions shall be as under :-**

1. Vehicle shall not be more than 6 years old. Only vehicles with taxi permit having valid documents like taxi permit, insurance ,fitness ,registration, pollution certificate etc shall be considered.
