

Terms & Condition:


The terms & conditions are as under:

1. The rates/prices are firm inclusive of all taxes.
2. **Photostat copy of R.C., insurance, road tax, driver license, PUC, & other relevant documents has to be submitted along with consent.**
3. All types of the liabilities of the vehicle will be borne by the contractor / vehicle owner e.g. taxi permit, insurance, fitness, registration & Pollution certificates etc.
4. The working hours for the hired vehicle would be 24 Hours per day.
5. Any compensation payable for damage caused due to accident by your vehicle/driver to any party/property shall be borne by you. The department will not be responsible for the same.
6. Income Tax & Other taxes will be deducted at source by the NIGAM.
7. In case of night halt at the place other than that of headquarter, a sum of Rs. 200/- per night shall be paid for the driver.
8. If any charges of Toll Tax, will be borne by the NIGAM on production of valid receipt.
9. **The vehicle should not be more than 6 yrs. Old & must be taxi permit vehicle.**
10. The payment shall be arranged on monthly basis by the A.O. (T&C), RVPNL, Hanumangarh against the verified bill by this office through RTGS/NEFT, after statutory deduction if any.
11. The offer period may be extended for 03 months if work found satisfactory in all aspect.
