- 1) You will have to arrange filter machine along with man for transformer oil filtration at site i.e 132 KV GSS, Kitasar, and oil testing kit having 100 KV Capacity.
- 2) Filtration of oil in transformer tank or in separate tank as the case may be and filling in transformer up to mark level in conservator.
- 3) Circulations of oil through filter plant in transformer till the required value of BDV and PPM achieved after all above process the oil shall be top up to the mark in the conservator. For carrying out above said work, the contractor will have to arrange his own filter Machine.
- 4) After receiving W.O., you shall have to depute your working team with filter machine and T&P within 15 days or on demand of the in charge of work.
- 5) Required electricity for above said work shall be provided by the RRVPNL, free of cost to the contractor. Required oil tank of suitable capacity would be provided by the RRVPNL at site, if required.
- 6) Permission for carrying out the work round the clock shall be arranged by the RRVPNL.
