

The salient point/ terms & condition as under

1. The Tender should be addressed to the Superintending Engineer (T&C), RVPN, Jodhpur ((Rajasthan) and tender are purchased from o/o the SE (T&C) RVPN New Power House Jodhpur
2. The procurement process shall be governed by RTPP Act 2012 and RTPP rules 2013
3. The procurement is being done through single stage bid.
4. The tender shall be submitted in closed/sealed envelope duly super scribed as "Hiring of vehicle (bolero Jeep, thar etc)"
5. The vehicle shall not be more than six years old. Only vehicles with taxi permit having valid documents shall be considered.
6. The tender cost (non refundable) and bid security as given above shall be deposited in cash and crossed demand draft /cheque respectively; Payable in the name of the AO (T&C) RVPN Jodhpur
7. Photocopy of registration certificate, Insurance, Road tax, Drivers license, Pollution under control and relevant documents are to be submitted with bid.
8. The vehicle is to be hired from 01.09.2016 to 31.3.2017 (7 Months)
9. The working hours for hired vehicles would be 24 hours per day.
10. Any Compensation payable for damage due to accident by your vehicle or Driver to any party/ property shall be borne by you. The Department will not be responsible for the same
11. The safety and security of the Vehicle shall not be responsibility of RVPN, and it will be Risk of Contractor.
12. Income tax and any other taxes if applicable will be levied/ charged as per RVPN norms only and service tax will be bear by RVPN.
13. Monthly Bill will be prepared and submit in the office of in charge of vehicle in triplicate. The same will be verified by in charge of vehicle and submit to the AO (T&C) RVPN JODHPUR. The AO (T&C) RVPN Jodhpur will arrange 90% payment of the bill and keep 10% amount as performance guarantee, which will be released after three month of completion of contract period.
14. Diesel will be provided by the RVPN on the average of 12km per litre and one litre Mobil oil for every 1000km run.
15. In case of any outage / damage of vehicle than substitute of the same may be arranged within 24 Hrs.
16. In case of non- availability of vehicle Rs. 200/- recovery will be made per day besides nonpayment of daily rent.
17. RVPN has right to reject any tender without arising any reason
18. Period of contract may be reduced as per requirement of vehicle
19. RVPN has all right to terminate the contract with a notice period of seven days
20. If service of hired vehicle found un satisfactory the contract would be terminated immediately without any notice period.
21. All other duties, taxes of vehicle is to be bear by vehicle owner, only toll tax , if any, paid by vehicle driver/ owner will be reimburse by RVPN on submission of receipt of toll tax
