### Terms & Condition:

The terms & conditions are as under:

1. The worker age should not be less than 18 years & not more than 50 years.
2. If the required persons are not available at the time of checking the penalty shall be charges at the twice rate of the amount as per order for the period for which he is absent.
3. If the performance is not found satisfactory the work can be withdrawn without giving any notice & without any compensation.
4. The contractor will observe the rules & regulations of the factory act; labor Laws & other statutory rules.
5. On availability of department person the scope can be reduced as per requirement & even the contract may be terminated after giving three days' notice & without any compensation.
6. Attendant should use proper uniform and shall be well behaved otherwise contractor shall be replace. Any loss caused due to theft, negligence etc. borne by the contractor.
7. Entire Rest House Building, gallery, hall, kitchen with all rooms, toilets & Lawn shall be kept neat & clean all the times. All consumable items, chemicals will be provided by the contractor.
8. The rate of the breakfast, lunch & dinner shall be fixed by the department as per general trend prevailing in the other rest houses and contractor is bound to service accordingly & Cooking Gas/ Fuels will be supplied by the department as per norms.
9. Proper records of visitors shall be maintain in a register as per direction of Engineer In-charge, which will be open to inspection of records by the prescribed authorities of the Nigam.
10. The person engaged should have knowledge of good cooking food & local language.
11. No charge for stay in rest house shall be accepted by the staff of the contractor without issuing cash receipt.
12. The Persons/Visitors allowed by Engineer In-charge shall be permitted to stay in Rest House. No private person shall be allowed to stay. If anyone found to stay unauthorized, charges @ twice the rates charges applicable to private person will be deducted from contractor's payment.
