- 1. Tender are invited for Consultancy service for forest clearance case submission online of 220 KV S/C Sirohi Pindwara Line and submit the report in hard copies as well as soft copy in the CD ,power point presentation and other data, as per requirement of MOEF,as per details enclosed and shall be received up to 03.00 PM on 20.03.2017 and will be opened on the same day at 03.30 PM in the presence of tendered who wish to be present at the time.
- 2. Tender received after the scheduled time may not be accepted and if delivered after that time is liable to be rejected.
- 3. Tenders should addressed to Executive Engineer (T&C) Rajasthan Rajya Vidhyut Prasaran Nigam Ltd., Sirohi and placed in a cover super scribed as "Consultancy service for forest clearance case of 220 KV S/C Sirohi Pindwara Line" due on 20.03.2017
- 4. Tender should be put in a tender box kept in the office or may be sent by post preferably under registered cover.
- 5. Contractor will have to arrange all software/ program/ machines required for carrying out the work at his own cost. No software/ program/ machines shall be provided by the department.
- 6. Eligibility Criteria:- Firms having the experience of successfully completion of the same type work of min. cost Rs. 56667/- (i.e. online submission of forest proposal) in Govt. Institutions are only eligible for the tender, for which they have to produce attested copy of certificate at the time of purchasing of tender document/ at the time of submitting the tender documents.
- 7. Contractor shall remove all the observation received from forest department at any level within 3 Days after intimation of consignee or RVPN representative.

- 8. Validity of Rates:- The rates should remain valid for a period of 60 days from the date of opening of tender after which it will be at the option of tender committee.
- 9. The tender should be completed in all respect and incomplete tender are liable to be rejected.
- 10. Payment of Bills:-90% payment of Bill will be made after completion of work and 10% after completion of guarantee period and shall be arrange by Account Officer (T&C) RRVPN, Sirohi through NEFT/ RTGS after verification by the consignee's.
- 11. The tender are to be written in only the rates should be given both in words as well as in figures. All conditions should be made clearly dated / initial.
- 12. The Work should be completed within 15 days from the date of issuing of work order and submit the report in hard copies as well as soft copy in the CD, power point presentation and other data, as per requirement of MOEF.
- 13. If the work not completed within time period penalty @ ½% per week or part thereof subject to maximum 10% of the delayed quantity will be recovered from the bill.
- 14. Conditional tender will not be accepted / considered.
- 15. EMD @2% shall be deposit by the lowest firm within 7 days from the opening of the tender, otherwise the tender shall be deemed to be cancelled.
- 16. The undersigned reserves the right to reject any / all tenders in part or full without assigning any reason thereoff.
- 17. All disputes shall be subject to jurisdiction of court in Rajasthan State only. In case of dispute the decision of SE (T&C), Sirohi will be final and binding on both the parties.
