2. The vehicle provider will have to submit bills (monthly basis) for arranging payment. 100% payment shall be made by the Sr. Accounts Officer (LD), RVPN, Jaipur through RTGS/NEFT against your monthly bills duly verified by this office.
3. The vehicle should be registered as Taxi, should not more than 06 years old and will be maintained in clean, good, and perfect condition by firm.
4. Copy of registration certificate, insurance, fitness, Road Tax, driver license, pollution under control certificate and other relevant documents are to be submitted with tender.
5. Any compensation payable for damaged caused due to accident by your Vehicle / Driver to any party / property shall be borne by you.
6. P.F of Vehicle Driver will be deducted as per Govt. rules/Act.
7. Performance security shall be taken from the individual/firm/travel agency as per provisions in Rajasthan Transparency in Public Procurement Rules 2013.
8. All taxes, except toll tax shall be borne by the firm, Reimbursement of all toll tax paid by the firm shall be made on production of original receipt of payment of all toll tax.
9. The rates as mentioned are firm and all legal deductions (if applicable) such as income Tax (TDS) shall be made as per law / rules applicable at the time of payment.
10. The Driver License shall be commercial.
