Consent is invited from competent and experienced firms/vehicle owners for deploying inspection vehicle (Maruti Swift-Dzire/Tata indica/Indigo car etc.) on the rates, terms and conditions approved by Finance Department GoR circular No. F.2(4)FD/SPFC/2017 Jaipur, dated 19.07.2018 and adopted by Rajasthan Rajya Vidyut Prasaran Nigam, Jaipur vide order No. RVPN/DS/GAD/F.Norms of Vehicle/18-19/D.512 Jaipur, dated 25.09.2018 as per details given below:-

The rates as per this circular are as follows:-

1. For first 1500 Kms. Or less,22,000/- per month(GST extra if applicable)
2. For additional running of vehicle (more than 1500 Kms ) the rate payable @ Rs.8.00 per km.
3. Hired vehicle shall be used anywhere as per jurisdiction of the office where deployed. In case of night halt other than that of head quarter a sum of Rs 300.00 per night shall be paid for the driver
4. The maximum ceiling of Rs. 30,000.00 per month GST extra if applicable) for 2500 Kms. for offices having jurisdiction of the entire state.

5. All taxes except toll tax shall be borne by the individual/contractor/firm. Reimbursement of toll tax paid by the individual/contractor/firm shall be made on production of receipt of payment of toll tax.

Other conditions shall be as under :-

- a) Vehicle shall not be more than 6 years old. Only vehicle with taxi permit having valid documents shall be considered.
- b) The vehicle is to be hired for the period i.e., 01.04.2019 to 31.03.2020 (Bill is to be submitted monthly and payment shall be arranged on monthly basis).
