In case vehicle is more than 6 years old and the condition of the vehicle is satisfactory, a relaxation of not more than 2 years (i.e. the vehicle should not more than 08 years old) can be given, by the approval of Secretary (Admn.),RVPN,Jaipur. The vehicle shall be maintained in clean, good, and perfect condition by firm.
2. Photo state copy of registration, certificate, insurance, road tax, pollution under control and other relevant documents of vehicle and driver license are to be submitted with acceptance.
3. The working hours for hired vehicles would be 24 hours per day.
4. Any compensation payable for damage caused due to accident by your vehicle/driver to any party/property shall be borne by you. The department will not be responsible for the same.
5. The hired vehicle may be parked in the premises of RRVPNL. If space is available, however, in this case, the safety & security of the vehicle shall not be the responsibility of the RRVPNL and it will be at the risk of the individual contractor/firm.
6. GST extra, if applicable.
7. All taxes except toll tax shall be borne by the individual /contractor/firm. Reimbursement of toll tax paid by the individual/contract/firm shall be made on production of receipt of payment of toll tax.
8. All legal deduction (if applicable) such as income tax (TDS) shall be made as per law /rules applicable at the time of payment.
9. In case of failure/brake-down of the vehicle, another vehicle will be arranged by the owner in 24 hours at his cost, otherwise, other vehicle will be hired from the market by RVPN at available rates and same amount will be deducted from the owner's bill.
