### ORDER

The Review Selection Committee has observed that a sealed cover envelope in respect of Shri M. L. Dhobi, JEN-II (E&M) has been opened and promoted to the post of AEN (E&M) vide order no. 992 dated 11.10.2017 against the vacancy of the year 2004-2005 on notional basis and his name is to be placed in the seniority of AEN (E&M) accordingly. The name of Shri Sheo Lal Chauhan, AEN (SC) in the seniority list of JEN-II (E&M) as on 01.04.2004 was appearing at Sen. No. 186 and the name of Shri M. L. Dhobi (SC) was appearing at Sen. No. 167 hence the name of Shri M. L. Dhobi, AEN (E&M) is to be placed in seniority of AEN (E&M) before Shri Sheo Lal Chauhan, AEN (E&M) as such Shri M. L. Dhobi is senior to Shri Sheo Lal Chauhan who was earlier promoted to the post of XEN (E&M) in the year 2017-2018, therefore the review DPC met on 15.11.2017 to review the selection of the post of XEN (E&M) against the vacancy of the year 2017-2018 under SC category and has observed that looking to above, Shri M. L. Dhobi was promoted as XEN (E&M) against the vacancy of the year 2017-2018 subject to final outcome of the Criminal Appeal No. 15/2001 pending before the Hon'ble Rajasthan High Court. Therefore, Shri Sheo Lal Chauhan, XEN (E&M) is required to be reverted to the post of AEN (E&M) hence the regular promotion order No. 189 dated 26.04.2017 of Shri Sheo Lal Chauhan, XEN (E&M) is hereby withdrawn.
