OFFICE ORDER

A provisional seniority list of Accounts Officers as on 01.04.2018 was issued on 02.04.2018. Three objections were received as follows:-


Shri Praveen Kumar and Shri Rahul Agarwal have requested that their name should be placed above the name of Miss Mradula Jain because she has been appointed after them. Miss Mradula Jain stood higher in the merit list securing 217 marks as against 180 and 203 marks secured by Shri Praveen Kumar and Shri Rahul Agarwal respectively. Since she is higher in merit, she is to be given seniority above them. Mere fact that she was given appointment later on from the reserve list because of non joining of another candidate does not debar her from getting her seniority as per the merit list. The Hon'ble High Court has in petition filed by Miss Mradula Jain also ordered to give her seniority.

The third representation is by Miss Mradula Jain to remove the word "PT" from the remarks column. Miss Mradula Jain was appointed as Probationer Trainee. Two years have not yet been completed from the date of joining. On completion of the same, word "PT" will be removed. In any case, it does not have any bearing on the seniority list and pay fixation. 
