


1. The controlling officer will ensure that the person concerned join to the post of Meter Inspector II within 15th days of this order, a copy of joining report shall be endorsed to this office.
2. The persons who are getting Selection Grade/ACP in the Pay Scale of Meter Inspector-II or higher will not be allowed further fixation of Pay in the Pay Scale of Meter Inspector-II.
3. In the event of non availing the benefit of promotion, request in writing about foregoing the promotion will be obtained by the Controlling Officer from him, by aforesaid date & forwarded to this office and an entry in this regard be made in the Service Book .
4. On forgoing the promotion, he will not be considered for promotion for next two years. the benefit of 2nd / 3rd Selection Grade/ACP shall be withdrawn from the date he forgoes the chance of promotion. as per order No. F&R/F.16/13/11/D.40 dated 25.07.97.
5. If any one of the above Meter Reader-II is under suspension or any DE/PE is pending against him. promotion shall be deemed to have been cancelled.
