

6. On promotion the workers are required to join their duty on new post within 15 days of issuance of this order.
7. No pay fixation benefit as a result of this promotion will be admissible to them if they are already drawing pay in pay matrix level-5 or in higher pay scale as a result of selection grade/ACP.
8. If above workers are under suspension or any DE/PE are pending against them or any penalty inflicted during last seven years, their promotion shall deemed to have cancelled.
9. If above workers are having more than two children on or after 01.04.12, their promotion shall deemed to have cancelled.
10. If any of the above workers, is not interested to avail promotion, the request in writing about foregoing the promotion shall be obtained by the controlling officer from him and forwarded to this office. On foregoing promotion, he will not be considered for promotion in next 2 DPC years, and benefit of selection grade shall be withdrawn as per order No. F&R/F.16 (13)-I/D. 40 dt. 25.07.97.
8. A copy of joining report of concerned employees be sent to this office within 15 days of issuance of this order.


