



**Terms & Conditions:-**

The controlling officer shall personally ensure compliance of following condition in respect of promotee UDC. In case following conditions are not staisfied in respect of above employee,the matter shall be reported by him to corporate office instead of taking joining report on the post of UDC.

1. That above promoted UDC is/are not under suspension and No DE/PE or criminal proceeding is pending against them.
2. That above employee(s) has/have not been penalized during last seven years.
3. That the employee(s) is/are not absconding from duty or not quit the Nigam's service.
4. That their tetimonials and certificates are verified from original.
5. All the aforesaid employees will have to join their duties within 15 days of issuance of order. In case the place of posting as mentioned against his/her name has been changed, they will join in the office where in working presently.

6. If any one is not interested to avail the promotion, request in writing about foregoing the promotion, shall be obtained by the controlling officer from him/her and shall be pasted in service book. On foregoing promotion he/she shall not be considered for promotion for next two DPC years. The benefit of 2nd & 3rd selection grade shall also be withdrawn from the date he/she foregoes the chance of promotion, as per order No. RSEB/F&R/F. 16(13)/I/D. 40 dated 25.07.1997.
7. Such Candidates who are getting selection grade/ACP in the Pay scale/Pay band and Grade pay of UDC or higher will not be allowed further fixation of pay in the Pay scale/Pay band and Grade Pay of UDC, however, if anyone is getting ACP in lower grade than UDC, he/she will be allowed only the difference of Grade Pay of the post of UDC.
8. Before joining on the post of UDC they will have to submit declaration duly signed by him and attested by Controlling Officer, that he/she has not more than two children after 1-6-2002
