The tender document comprising specification & other details can be obtained from this office (Ramgarh) by depositing Tender cost through cash /demand draft/banker cheque payable at Jaisalmer on any working day. The demand draft/ Banker cheque for tender Cost/earnest money should be drawn in favour of the Sr. Accounts Officer (RGTPP), RVUN, Ramgarh payable at Jaisalmer. The EMD shall not be accepted in the form of cash & shall be furnished in separate envelope with tender. The tenders will be sold up to 1.00 PM ( Ramgarh Office) and shall be received in the office ( Jaisalmer OR Ramgarh ) up to 4.00 PM of the previous day of date of tender opening. The tender will be opened at 3.30 PM ( Ramgarh Office) on date of tender opening as indicated above in presence of Tenderers who wish to be present. The purchase of tender document & deposit of earnest money is essential for participation. The details of EMD should be clearly mentioned on the envelope.

Above tender will be submitted in two separate envelopes. The first envelope Techno-commercial bid (Part A) shall give details of pre qualifying criterion / requirement and second envelope (Part B) shall be price bid. The price bid shall be opened only after assessment of competence & meeting the qualification requirement. ### **GENERAL CONDITIONS FOR WEBSITE**

1. Purchase of tender specification (non transferable) is essential for participation in bid and can be had from the office of the undersigned (Ramgarh) on any working day from 11.00 AM to 4.00 PM and upto 1.00 PM on previous day of date of opening by remitting the tender cost (non refundable) as above either by cash or DD payable at Jaisalmer in favour of Sr. Accounts Officer, RGTPP, RVUNL, Ramgarh. The tenderer shall make request for each tender separately.
2. The tender documents can also be downloaded from the site [www.sppp.rajasthan.gov.in](http://www.sppp.rajasthan.gov.in) . DD of tender cost shall be attached separately with the filled tender documents.
3. In support of tender's qualifying requirement, the tenderer must enclose the copies of purchase / work order secured for supply / work of similar type of items from other thermal power stations/ Govt. department and proven experience.
4. Bid shall be furnished in two parts in separate envelope. Part 'A' shall contain Technical and commercial details while Part 'B' shall contain only price bid and these shall be enclosed together in single envelope.
5. Tender documents will be issued only to prima facie qualifying parties after scrutiny of documents furnished by in tending tenders along with their request for issue of tender documents. However such issue of tender document will not automatically construe that bidder are considered qualified. Such qualification will be reviewed at the time of evaluation of bids.
6. The tenders shall be accepted up to 4.00 PM on the previous day of date of opening in the office of the undersigned ( Jaisalmer OR Ramgarh ) and these shall be opened at 3.30 PM ( Ramgarh Office ) on the date of opening as indicated above in presence of tenderers or their representatives who may like to be present. If the date of tender opening happened to be a holiday, the tenders will be accepted / opened on next working day.
7. Tender without earnest money & details super scribed on the envelope or accompanied inadequate amount shall not entertain and in such cases tenders shall not be opened. EMD in form of DD/ Banker's Cheque in favour of Sr. Accounts officer (RGTPP), RVUNL, Ramgarh payable at Jaisalmer shall be furnished in separate envelope along with tender. The EMD shall not be accepted in BG or in any other form.

8. This office reserves the right to cancel/reject any or all tenders at the time of evaluation without giving any reasons. Notwithstanding anything stated above the purchaser reserves the right to assess the bidders capability and capacity to perform the contract, if circumstances warrant such assessment in the overall interest of RVUN, the decision of purchaser in this regard shall be final.

- A. The participating bidder should have service tax registration with central excise dept., PF registration, PAN, TIN/GST , and labour license if required.
- B. The bidder should have experience of similar type of work in power plant/any industries during last seven years having value equivalent to single order of Rs. 1.8500 Lakh or above OR Two orders of Rs. 1.10 Lakh OR Three orders of Rs. 75000.00
- C. Bidder should have minimum financial turnover equivalent to 2,00,000 or above.
- D. Satisfactory performance certificate of the work experience not below the rank of Superintending engineer or order placing authority of the concern organization.
