**(A) For TN-2461 BM (Extension)**

1. Average Annual Financial Turn Over in the preceding three completed financial years as on date of bid opening should not be less than Rs. 161000.00 (50% of the total estimated value of the work)
2. The bidder must have an experience of having successfully executed / completed the contract for Online safety valve setting by trevi testing method & online leak sealing services in any of thermal power plant(s)/ Gas power plant(s)/any industries during last 7 years ending last day of the month previous to bid opening date with either of the following executed value(s) of the contract(s):
  - a. Three executed/completed contracts, as above, costing not less than the amount equal to 40% of the estimated cost each
  - or
  - b. Two executed/completed contracts, as above, costing not less than the amount equal to 50% of the estimated cost each
  - or
  - c. One executed/completed contract, as above, costing not less than the amount equal to 80% of the estimated cost.
3. Satisfactory performance certificate or satisfactory work completion certificate for above executed works should be signed by officer not below the rank of Superintending Engineer or order placing authority of concerned organization.
4. The participating bidders should have GST registration with Central Excise Department, PF registration, PAN card, ESI registration and labour licence (if required) and class A electrical licence (if required).
