CIRCULAR

Sub:- 'Amnesty Scheme' for disconnected consumers of all categories (disconnected upto or prior to 31.03.2019) for realization of outstanding dues.

An Amnesty Scheme was introduced vide Circular No AVVNL /ACE (HQ) / XEN(C-II) / F. /2019-20/ D 4802 dt 05.12.2019 (Comml Aj-798) to allow concessional package for a period of 01.12.2019 to 31.01.2020 to motivate the disconnected consumers of all categories (disconnected upto or prior to 31.03.2019) to settle their outstanding dues. In continuation to this, partial modifications are made as hereunder:

- i) Reconnection shall be allowed for domestic / Non- domestic category consumers disconnected on or after 01.04.2007 after deposition of full principal outstanding amount and reconnection charges as prescribed in TCOS-2004 along with cost of laying any additional line required and payment of security charges separately as per prevailing rules. The disconnected connections of other categories shall be reconnected if feasible as per prevailing Nigam's rules.
- ii) Point No 10 of Comml Aj 798 is hereby deleted and is replaced by aforesaid point.
- iii) Annexure 'A' is revised as enclosed.

Other terms & conditions will remain the same as prescribed in Comml Aj-798.
