ORDER


Sub:- "Amnesty Scheme" for permanently disconnected consumers of all categories (disconnected prior to 31.3.2011) for realization of outstanding dues.

With a view to recover the outstanding dues from the PDC consumers disconnected prior to 31.3.2011, it has been decided in the Discom Coordination Forum in its 33rd meeting held on 16.2.2012 to allow concessional package for a period from 1.3.2012 to 31.3.2012, if the consumer deposits the total outstanding dues up to 31.3.2012.

The above concessional package will be applicable for the PDC consumers of all categories disconnected up to or before 31.3.2011. Accordingly, if the PDC consumer deposits outstanding amount in one stroke before 31.3.2012, then the applicable interest and DPS/LPS shall be waived-off. This scheme/package will be applicable with the terms & conditions as below:-

1. This Scheme shall be applicable for the period 01.03.2012 to 31.3.2012.
2. One time payment is to be taken and no installment is allowed.
3. Under this scheme, the benefit would be given only if the consumer voluntarily undertakes to withdraw all the court cases pending in any court of law/consumer forum/any other forum related to the outstanding dues.
4. This Scheme shall be applicable irrespective of whether disconnected consumer wants reconnection or not.
5. For availing the concession package, the consumer shall require to apply to the concerned Assistant Engineer for all categories of consumers except large industrial category. In case of LIP, they will have to apply to the Sr. Accounts Officer (Comml.) in the format enclosed at Annexure 'A'.
6. The outstanding dues should be worked-out after adjusting of security deposit if not already adjusted.


