ORDER

Sub :- Billing of consumers if the connected load / contract demand is revised (increased or decreased) in the middle of the month.

Large industrial consumers have represented to the RERC in respect of billing their consumption. They have complained that when any decrease or increase in connected load/contract demand is effected in the middle of the month, the demand charges, minimum billing and fixed charges as well as blocks/slabs of energy charges are recovered on prorata basis. But the power factor surcharge/incentive is not calculated on prorata basis and instead it is calculated for whole of the month.

The Rajasthan Electricity Regulatory Commission had considered the request of the industrialists. It has been directed that whenever any change in contract demand/connected load is effected in the middle of the month, bills for each period be prepared considering all the charges like demand charges, fixed charges, minimum billing, power factor surcharge/incentive, on prorata basis, separately for each period.

It is, therefore, enjoined upon all the concerned officers to comply with the aforesaid directions. Old cases, however are not required to be reopened.


