

Sub:- "Amnesty Scheme" for waiver of LPS/DPS for agriculture consumers of Chirawa Division associated with Kisan Vikas Sansthan, Pilani.

With a view to recover the outstanding dues from the agriculture consumers of Chirawa Division associated with Kisan Vikas Sansthan, Pilani who could not deposit their bills due to court cases by Kisan Vikas Sansthan, it has been decided in the 183rd meeting of the Board of Directors of the company held on 25th day of May, 2011 that to launch a scheme for waiving off the LPS/DPS for all agriculture consumers of Chirawa division only of Jhunjhunu Circle subject to the following conditions :

1. This scheme shall be applicable for the consumers of Chirawa division only who have not deposited the bills due to court cases by Kisan Vikas Sansthan.
2. Under the scheme, the Agriculture consumers have to deposit complete outstanding dues in one stroke for getting the benefit of LPS/DPS.
3. The benefit of the scheme would be applicable only if the consumers voluntarily undertake to withdraw all the court cases pending in any court of Law/Consumer Forum/ any other forum related to the outstanding dues.
4. All the consumers seeking the benefit under the scheme shall apply to the concerned AEN in prescribed format enclosed at Annexure-A to be made available in the concerned Sub division offices.
5. The Scheme will be applicable from 01.06.2011 to 30.06.2011 only.


