Sub:- Procedure for depositing defective meters in store.

The matter of disposal of accumulated meters lying with sub-divisions was discussed in the Sr. Officers meeting and following revised procedure is hereby prescribed for depositing defective meters in Stores.

- (i) The meter removed from site will be read through HHT in sub-division (if infrared port/optical port is available) and the reading will be entered in MCO.
- (ii) If the infrared port/optical port is not available, and meter could not be read through HHT, then average will be charged for defective/display off period as per rules.
- (iii) If the meter can be read through HHT, but could not be read in sub-division due to non-availability of HHT or due to any other reason then the meter will be sent to meter lab for the same.
- (iv) List of defective meters will be prepared by sub-division for GP failed/BPG failed meters separately, Firm wise/TN-wise in the following format:-
