Order

Sub:- Detailed Guidelines & Procedure for Net Metering and Grid Connectivity of Grid Connected Rooftop & Small Solar Photovoltaic Systems.

RERC has framed RERC Net Metering Regulation – 2015 and notified it vide regulation No. RERC/Secy/Reg.-II dated 26.02.2015. These Regulations have been notified in Govt. Gazette Notification dated 16.03.2015 and effective from the date of Gazette notification. Detailed Guidelines & Procedure for Net Metering and Grid Connectivity of Grid Connected Rooftop & Small Solar Photovoltaic Systems were issued vide order Comml Aj -580.

Subsequently meeting was held on 14th May, 2016 under the Chairmanship of Pr. Secretary (Energy), GOR to discuss various issues related to Rooftop Net Metering and as per the Minutes of meeting the following amendments are made in the following clauses of the order Comml Aj-580 as below:

- **The clause (B) “Procedure for application” sub clause (9) & (10) of the Comml Aj-580 shall be read as:**


B-(9): For expeditious disposal of issuance of NOC and execution of net metering Agreement the Assistant Engineer (O&M) is authorized for issuance of NOC and executing net metering agreements as per Annexure-V.

- **The clause (H) “Reporting Requirement” of the Comml Aj-580 shall be read as:**

H : “The DSM cell of Discom shall be overall incharge for reporting requirements. The Concerned Circle Superintending Engineers of Ajmer Discom shall report the following, monthly information in first week of each month and yearly compiled information by June 1 of each year to the XEN (DSM) who will act as Nodal Officer for Net Metering. The Nodal Officer will be responsible for monitoring the status of issuance of NOC, maintaining monthly record of application received, sanctioned load/ demand,, date of issue of NOC, sanctioned capacity of SPV and date of installation and will also ensure to get uploaded the information on website on June 1st of every year. He will also be responsible for redressing all the issues related to Net-Metering”

1. Total number of Eligible Consumers interconnection at the end of the previous financial year;
2. Total kW capacity of the Eligible Consumers interconnected at the end of previous financial year;
3. Total kWh received by the Eligible Consumer from the Ajmer Discom by month and by year for the previous financial year;
4. Total kWh of solar energy generated by the Eligible Consumer by month and by year for the previous financial year;
5. Total kWh delivered by the Eligible Consumer to the Ajmer Discom as per billing cycle and by year for the previous financial year;
6. For each Eligible Consumer interconnection:
 - a) Solar technology utilized
 - b) Gross power rating
 - c) Geographic location, and
 - d) Date of interconnected.

• **The Annexure-II Schedule of Charges at Sr. No. 2(b) “Non Domestic” may be read as “Non-Domestic and others”.**
