Order

Sub: Levy of Electricity Duty on consumption of Self Generated Energy for any purpose in respect of energy generated by captive power generating plants other than D.G. Sets.

Ref:- Chairman-Discoms order No.CE(PPM)/F./D. 73 Jaipur dt. 11.03.2015

On the above captioned subject & order under reference wherein detailed directions were issued regarding installation & testing of meters installed/to be installed on the captive power generating plants other than D.G.Sets for levy of Electricity Duty on consumption of self generated energy for any purpose. The Commissioner, Commercial Taxes Department, Rajasthan now vide its notification dated 18.03.2015 authorized SE(M&P) of respective Discoms within their respective area assigned to them to exercise all the powers conferred to the Electrical Inspector under sub-rule-3 of Rule-38 of the Rajasthan Electricity (Duty) Rule-1970, in supersession of their notification dated 18.08.2004 wherein AEN(O&M) were authorized.


In this regard following is further clarified:

1. The term meter shall include Current Transformer, Voltage/Potential Transformer, wiring between them and meter box/panel.
2. The designated SE(M&P) are required to arrange the testing of the meters along with metering equipments after depositing the necessary testing fee for already installed/to be installed meters by the persons generating electricity through their Captive Power Generating Plants and get the metering panel sealed after installation & testing and shall also furnish copy of JIR to the Commercial Taxes Department and CAO (Control), JPD, Jaipur.
3. The requirement & specification of meter/metering equipment shall confirm to the specification of the Nigam and RERC metering Regulation-2007.
4. Further the routine testing of meters and metering equipments (CTs,PTs or CT-PT Sets) of these captive power generating plants shall also be carried out by the designated SE(M&P) and O&M Wing jointly on the similar lines as per the practice in vogue for AVVNL's consumers.

5. The concerned SE(M&P) and concerned AEN(O&M) of the respective area shall keep a record of testing of metering equipment of such captive power plants.
6. The concerned AEN(O&M) shall also keep record of monthly energy consumption of self generated energy for any purpose in respect of energy generated by above captive generating plant other than D.G.Set, showing break up of energy generated, energy consumed for his own use/consumed by his sister concern through open access/supplied to others free of charge in Annexure-B enclosed herewith as also circulated vide above referred order and submit the same on 25th of every month for the previous month consumption.

It is enjoined upon all concern to ensure strict compliance of the directions.
