Vide above cited letters, it was requested to arrange to file challans cases before Special Courts after obtaining orders of appointment of OIC and panel advocate (as public prosecutor) from the concerned Superintending Engineer of O&M wing. But, it has been reported from Ajmer circle that police officers/ SHOs are filing cases in Spl. Court, without obtaining such order from Superintending Engineer (ADC/ACC), AVVNL, Ajmer.

It is therefore requested to instruct all SHOs of APTPS to make proper compliance of orders under reference and obtain orders of appointment of advocates (PP) from the concerned Superintending Engineer of (O&M) circles by sending details of the cases alongwith relevant documents, so that information of such cases be kept in the record of legal cell of circle office for proper monitoring.

It should also be instructed to them to send the copies of decisions of Spl. Courts, opinion of advocate and other relevant record to the concerned Superintending Engineers for further action, well in time.
