Sub.:-Ban on strike under RESMA-1970 by the State Government.

In reference to Chairman Discom letter No. JPD/CPO/DDP(HQ)/D. 3154 Jaipur/07.12.2015 and consequent upon issuing of Notification dated 2.12.12 by the State Government through Home (Group-9) Department, the activities of all offices of the Power Sector Companies have been declared as essential services under the Rajasthan Essential Services Maintenance Act (RESMA)-1970. And the Strike in all Power sector Companies has been ban. A copy of the said Notification has already been endorsed to you by the DDP(HQ), AVVNL, Ajmer vide No. 410 dt. 03.12.15 and No. 6803 dated 04.12.2015.

The Rajasthan Vidyut Takniki Karamchhari Association vide letter dt. 24.11.15 served a Notice to the CMD/MD of all Power Sector Companies to go on **TOOL DOWN STRIKE** w.e.f. 8.12.15 for indefinite period in support of demand of enhancement of Grade Pay to Rs. 2400/- for Technical Helpers.

You are, therefore, advised to ensure the following:-

1. No employee be sanctioned leave of any kind. The leave already sanctioned be cancelled and the employee be called to report on duty.
2. The Employees who participate in Strike be marked "ABSENT"
3. No employee affiliated to any Trade Union goes on strike or stages Dharna and disrupt the electric supply. In case the employees affiliated to any Trade Union stage Dharna/ Demonstration etc, the vedigraphy of the same be got done.
4. The names of all Trade Union Leaders with name of office, residential address & Mobile number, be sent to this office as well as to local Police Administration.
5. The names be also intimated to the local Police Administration, whosoever instigates the strikers and obstruct the employees coming to office.
6. The SE(O&M), will Co-ordinate at their level with the RVPN Officers to maintain proper supply of Electricity.
7. Be constantly in touch with your subordinate offices and leaders of Union to keep atmosphere co-ordial and harmonious.

The above instructions be strictly adhered to.
