## CIRCULAR

As per provision of MSMED Act., 2006 if the payment is delayed beyond schedule date than an interest at the rate of three times of Bank rate shall be payable to MSME Industries.

As per D.O. letter No. D.164 Jaipur, 20 April, 2021 of Chairman, Discoms, to avoid delay in payment in future, following directions have been issued to ensure compliance of provisions of MSMED Act, 2006 regarding payment :-

- (1) While issuing Purchase Orders/Work Orders in respect of Capital/O&M Expenditure, the Sufficient funds tie-up should be ensured.
- (2) Work order which are already made and sufficient funds tie-up is not available, may be deferred till the funds tie-up has been made.
- (3) Ensure the inventory control so that the funds are not held up for long.

In view of above, if any financial liability arises due to non-compliance of provisions of MSMED Act., 2006, the responsibility of concerned officer should be fixed and the case should invariably be brought in the BOD of AVVNL for taking decision on recovery of the amount.
