

11	Other terms	-	1. The 50% fee will be payable after filing of writ/reply/appeal etc. & balance 50% will be paid after final disposal of the case. 2. If any point regarding rates/fees is left then the same shall be decided after seeking approval of the Hon'ble MD Ajmer Discom.


