**Sub:- Regarding renewal of PMCF Card of existing pensioner under RRVPMCF Scheme.**


The BoT-PMCF in its 14<sup>th</sup> meeting held on 29<sup>th</sup> December, 2011 decided to take Term Membership Fee (for 10 years) from the existing pensioners registered with various circles of Power Sector Companies under Rajasthan Rajya Vidyut Pensioner Medical Concession Fund Scheme-2000. The provision of depositing Annual Renewal Fee from existing pensioners has been deleted from 1<sup>st</sup> April, 2012.

Accordingly all the existing pensioners have to deposit the Term Membership Fee (for 10 years) as per amended provision no. 5(ii)(a)(I) of RRVPMCF Scheme-2000 issued vide order no. No. RRVPNL/CAO(P&F)/Sr.AO/Pen/PMCF/F./D. 1199 dated 27.3.12 up to 31<sup>st</sup> May, 2012 for reimbursement of medical claim.

Further BoT has also decided that period of Term Membership Fee shall be limited to 10 years only. Accordingly those pensioners who have already deposited One Time Membership Fee will be required to get renewed the PMCF card as per prevailing rates after completion of 10 years from the initial date of depositing the amount.




