**ORDER - 7**

**Sub: - Amendment in Travelling Allowance Rules.**

The Board of Directors in its 11<sup>th</sup> meeting held on 20<sup>th</sup> Oct. 2001 has decided to make the following amendments in the erstwhile RSEB Travelling Allowance Rules.

In the said Rules: -

I. The existing rule 2(A) (1) be substituted by the following: -

“2(A) (1)” For the purpose of calculating Travelling Allowance other than Halting Allowances, AVVNL employees are divided in four categories: -

<u>Categories</u>	<u>Class of AVVNL Employees</u>
1. Category “A”	CMD/Directors/Employees drawing pay of Rs. 10,000/- per month or above.
2. Category “B”	Employees drawing pay of Rs. 6500/- or above but below Rs. 10,000/- per month.
3. Category “C”	Employees drawing pay of Rs. 4000/- or above but below Rs. 6500/- per month.
4. Category “D”	Employees drawing pay below Rs. 4000/- per month.

II. The existing Rule 2(A) (2) be substituted by the following: -


“2(A) (2)” For the purpose of calculating Halting Allowance AVVNL Employees are divided in Six Categories: -

<u>Categories</u>	<u>Class of AVVNL Employees</u>
1. Category “I”	CMD/Directors/Employees drawing pay of Rs. 16,400/- per month or above.
2. Category “II”	Employees drawing pay of Rs. 9000/- or above but below Rs. 16,400/- per month.
3. Category “III”	Employees drawing pay of Rs. 5900/- or above but below Rs. 9000/- per month.
4. Category “IV”	Employees drawing pay of Rs. 5000/- or above but below Rs. 5900/- per month.
5. Category “V”	Employees drawing pay of Rs. 3500/- or above but below Rs. 5000/- per month.
6. Category “VI”	Employees drawing pay below Rs. 3500/- per month.

- III The existing figures Rs. 4500/-, Rs. 3000/- and Rs. 1800/- as appearing in Appendix "A" (Part - I) Col. 1 be substituted by the figures Rs. 14,300/-, Rs. 10,000/- and Rs. 6500/- respectively.
- IV The existing figure Rs. 3700/- as appearing in Appendix "A" (Part -I) Col. 3 under Note - 4 be substituted by the figure Rs. 12,000/-
- V The existing figures Rs. 3700/- and Rs. 3000/- appearing in Appendix "A" (Part - III) Col. No. 1 be substituted by the figures Rs. 12,000/- and Rs. 10,000/- respectively.

If an employee happens to fall in a lower category due to revision of the categorisation, he/she may continue to draw the travelling allowance based on categorisation of pre-revised scales.
