CIRCULAR

It has been brought into notice that many times medical claims sent for Sub-Committee's approval duly recommended by the concerned Jurisdiction Level Committee, are not Pre-Audited properly as well as the deposition of prescribed PMCF fee has not been taken in view while passing & recommending the medical claims, due to which such claims have to be returned on the basis of non-admissibility which results in increase in litigations by the pensioners.

Therefore, for the purpose of passing of medical claims of pensioners without any impediment and avoiding unnecessary litigations in future, it is enjoined upon all the circles Accounts Officers to review the PMCF Whole Life Membership fee paid by each & every registered pensioner in their office before passing their claims in accordance with the rates given below and as notified from time to time under RRVPMCF Scheme:-
