Sub:- Subscription to the Rajasthan Rajya Vidyut Pensioners Medical Concession Fund, 2000.

The Chairman and Managing Director, RVPN, in exercise of powers conferred vide order No. RVPN/CAO/P&F/PMCF/D.3957 dated 06.08.2001, is pleased to adopt order No. F.1(5)FD(Rules)/ 2009 dated 08.12.2016 issued by the Finance Department, GoR, vide which the rates of subscription to the Rajasthan Pensioners Medical Fund has been revised w.e.f. 01.12.2016.
