Sub:- Amendments in E/W RSEB, Technical Workmen Service Regulations, 1975. (Enforced in AVVNL)

The following amendments are hereby done w.e.f. 01.04.2017 in Schedule -III of E/W RSEB, Technical Workmen Service Regulations, 1975 (Enforced in AVVNL):-

1. In column 5, against the post of Meter and Relay Tester & Repairer-III, the existing entries shall be replaced by the following:-

*"50% from Helper-I with Secondary or equivalent and 5 years experience and 50% from amongst Helper-I/Technical Helper with ITI/NAC and 3 years experience."*

*Note:- In case of non availability of suitable candidates inder ITI or non ITI quota as the case may be, such unfilled vacancies may be filled up from the other quota provided that the difference in experience amongst these categories remains two years or more.*

2. In column 5, against the post of Meter Inspector-I, the following provisions shall be inserted:-

*"Provided that if vacant post of Meter Inspector-I could not fill up due to non availability of Meter Inspector-II/ Meter Reader-I having 5 years experience, the employees having 10 years experience by clubbing the services rendered on the post of MR-I/MI-II and MR-II be considered for promotion."*

This is subject to ratification by the Board of Directors.
