Sub:- Amendment in order No. RSEB/Karmik/TE/F.21(336) II/D. 1885 dt. 15.07.2000 for appointment/re-designation of in-service JEN-II to JEN-I who already possessed BE/B.Tech./AMIE qualification before appointment as JEN-II.
