## ORDER

As per order No. F.12 (28) FD/ Tax/2010-Pt.I- 114 dated 08.10.2014, issued by the Finance Department (Tax Division), GoR, enterprises engaged in the tourism sector have been allowed 25% exemption from payment of Electricity Duty for a period of 7 years under the RIPS-2014.

Benefit under the scheme shall be available to the new as well as existing enterprises, who invest and commence commercial production under the provisions of the scheme made by the State Govt. The above exemption shall however be subject to the condition of production of "Entitlement Certificate" of the empowered committee/ authority of the State Govt. by the consumer.

To implement the above in billing, a new letter code "e" (small) is hereby allotted for suffixing the same at 5<sup>th</sup> place of the six digit tariff code. After receipt of the necessary "entitlement certificate" as above, the unit officer/ARO shall revise/enter the tariff code of the consumer concerned through the input entry MF-1/MF-2, available on the system.

The Unit officers & ARO shall further ensure that after completion of the exemption period of 7 years, the tariff code of the consumer concerned is revised again so that no exemption is allowed to such consumers beyond the admissible period. With a view to monitor such cases, register prescribed vide order No. 1007 dated 06.06.2011 (REV-AJ-100) should also be maintained in all the units without fail.
