**ORDER**

**Sub: - Grant of Dearness Relief to the Pensioners of AVVNL.**

In exercise of powers conferred vide order No. AVVNL/CAO (R&C)/AAO (Rule)/F-15/OO/D .3416 dated 05.12.2011, (AVVNL-Rule-527) the Managing Director, has been pleased to adopt the State Government's order No. F. 12(3)/ FD(Rules)/ 2013 dated 17.11.2016 issued by the Finance Department (Rules Division), Government of Rajasthan and the existing rate of Dearness Relief payable to the pensioners as mentioned in the order no. AVVNL/ CAO (R&C)/ AAO (Rule)/ F.4/ OO/ D. 263 Dated 22.04.2016 (AVVNL- Rule- 717) shall be revised from 125% to 132% w.e.f. 01.07.2016.

Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to next higher rupee. The provisions of this order shall also be applicable to the pensioners of erstwhile RSEB.

The amount of Dearness Relief at increased rates for the month of November, 2016 and onwards shall be paid along with pension for respective month and the arrears of increased Dearness Relief i.e. 125% to 132% for the period from 01.07.2016 to 31.10.2016 will be arranged/released in one installment with the pension for the month of November, 2016 payable in December, 2016.
