Sub:- Amendment in the Employees General Provident Fund Regulations, 1988.

The Board of Directors, RVPN, in its 203rd meeting held on 24.01.2012, has accorded its approval to substitute the existing proviso to Regulation 20 (ii) of the Employees General Provident Fund Regulations, 1988 by the following, namely: -

"Provided that the rate of interest to be allowed on claims for refund, for the broken currency period shall be the last declared rate on GPF and if the rate of interest declared for any current year happens to be less than previous year's declared rate, then it would accrue as bonus to the outgoing member and the claims settled under this proviso shall be final.

Provided further that interest upto and for the current month shall be payable on the claims which are authorized on or after the 25th day of a particular month alongwith actual payment after the end of the current month."
