**AVVNL-Rule - 586**

**ORDER**

**Sub :- Revision in the rate of Electricity Allowance being paid in the Rajasthan Power Sector Companies and in the rate of earning Privilege Leave and its maximum limit of accumulation.**

Pursuant to the Co-ordination Committee decision taken in its 159<sup>th</sup> meeting held on 14.09.2012, it is hereby ordered to adopt the Energy Department, GoR's letter No. F.4 (7)Urja / 2010 dated 07.09.2012 and accorded its approval in respect of the following to make necessary amendments in the relevant regulations/ norms accordingly :

- (i) The existing rate of electricity allowance being paid to the Nigam employees (pre-revised pay scale 1-6A, now scale no. 1-9) be enhanced from Rs. 10/- per month to Rs. 100/- per month with effect from 07.09.2012.
- (ii) In the Rajasthan Electrical and Mechanical Department Technical Employees Leave Rules, 1955 as adopted by the erstwhile RSEB as well as AVVNL, following amendments be made with effect from the financial year 2012-2013 :
  - (a) The rate of earning privilege leave (PL) as appearing in Rule 10 of the aforesaid rules is substituted by "30 days" in place of "24 days".
  - (b) The maximum limit of accumulation of privilege leave (PL) as appearing in Rule-12 (c) of the aforesaid rules be substituted by "300 days" in place of "180 days".
- (iii) In the AVVNL Employees Service Regulation, 1964, following amendment be made with effect from 07.09.2012, namely :

"the figure '12' as appearing in the existing regulation No. 45 (A) (ii) of the AVVNL ESR, 1964 be substituted by the figure '15'."

This is subject to ratification by the Board of Directors.
