Sub :- Amendment in the Ajmer Discom-Employees Service Regulations,1964.


In exercise of the powers conferred vide order No. AVVNL/CAO/Rules/ F/(13)/D-505 dated 03.11.2001 (Order-11), the Managing Director has been pleased to adopt Notification No. F.1 (4)FD/Rules/98 dated 12.12.2012 issued by the Finance Department, Government of Rajasthan and make consequential amendments in the Ajmer Discom-Employees Service Regulations, 1964.

Accordingly, after the Regulation-45 (2) (a) appearing in the Ajmer Discom- Employees Service Regulations, 1964, the following new proviso shall be inserted, namely-

“Provided that where the privilege leave at the credit of a Nigam employee as on the last day of December or June is 300 days or less but more than 285 days, the advance credit of 15 days privilege leave on the first day of January or July shall be made as provisions contained in Regulation 45 (2) (a) above and the leave account of such advance credited privilege leave shall be kept separately and against which privilege leave taken by a Nigam Employee during the half year shall first be adjusted during that half year and balance, if any, shall be credited to the leave account at the end of the half year, subject to the condition that balance of such advance credited privilege leave plus privilege leave already at credit do not exceed the maximum limit of 300 days.”

This order shall come in to force with effect from 01.01.2013.
