CLARIFICATION

Sub: - Rajasthan Civil Services (Medical Attendance) Rules, 2013.

Rajasthan Civil Services (Medical Attendance) Rules, 2013 were adopted by the Nigam vide order no. 17 dated 03.06.2014 (F&R-885), wherein it was decided that private hospitals already recognized/empanelled by RVPN in the past i.e. before 15<sup>th</sup> May, 2014, shall remain valid. Some of those empanelled hospitals has been included by the GoR in Appendix-III as referral hospitals of the above mentioned rules.

Accordingly, it is clarified that any of the referral hospital exists in the list of private empanelled hospital of the Nigam, shall be treated as empanelled hospital for all purpose, unless & until it is deleted from the list of empanelled hospitals of the Nigam.
