ORDER

Sub:- Procedure for sanction of additional pension/family pension admissible to old pensioners/family pensioners on attaining age of 80 years or above at par with Government pattern.

The Co-ordination Committee in its 187th meeting held on 30.12.2015 has decided that Additional Pension shall automatically be increased at par with the government pattern taking into consideration the date of birth of pensioner/family pensioner and alive certificate, by the Pension Payment Authority on his own.

Accordingly, sub-para (iv) (i.e. "Additional Pension") of Nigam's order no. AVVNL/CAO/AAO/Rules/F-RPS-08/D.3076 Ajmer, dt: 01.10.2008 (AVVNL-Rule-293) regarding Revised Pension Rules, 2008 shall be substituted by the following, namely:-

"(iv) The Additional Pension shall automatically be increased at par with the government pattern as prescribed in Rule 54A of Rajasthan Civil Services (Pension) Rules, 1996, taking into consideration the date of birth of pensioner/family pensioner and alive certificate, by the Pension Payment Authority on his own."

This bears the approval of the Managing Director, AVVNL and is subject to ratification by the Board of Directors of the Nigam.


