(ii) The following note be inserted in column 5 against the nomenclature Electrician-II, Lineman-II, SSA-III :

NOTE :- In case of non-availability of suitable candidates under ITI or Non-ITI quota, as the case may be, such unfilled vacancies may be filled up from the other quota provided that the difference in experience amongst these categories remains two years or more.
