**ORDER**

**Sub: Amendment in RSEB T.A. Rules, 1971.**

In exercise of the powers conferred vide order No. AVVNL/ CAO(R&C)/ AAO(Rule)/ F.15/00/ D.3416 dated 05.12.2011, the Managing Director, AVVNL, is pleased to adopt the order No. F.6(3)/ FD/ Rules/2012 dated 18.05.2016 regarding amendment in Rajasthan Traveling Allowance Rules, 1971. Accordingly, following amendments are hereby made in the RSEB T.A. Rules, 1971, namely: -

- (i) Words "All state Capitals in India (except Jaipur) including Delhi" appearing in item number (iii), column 3 (Ordinary Rates) of Appendix-'A' (Part-II) appended as Annexure-II shall be substituted by the words "All state Capitals in India (except Jaipur) including Delhi and places connected by air-services".
- (ii) In Appendix-'B' (II) i.e. daily allowance rates for boarding and lodging appended as Annexure-V, column 2 and 3 shall be substituted by the following: -
