NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 9 of the Rajasthan Stamp Act, 1998 (Act No. 14 of 1999), the State Government being of the opinion that it is expedient in public interest so to do, hereby orders that stamp duty chargeable on the instruments of lease executed in respect of land allotted to the Rajasthan Rajya Vidyut Prasaran Nigam Limited, Rajasthan Rajya Vidyut Utpadan Nigam Limited, Jaipur Vidyut Vitran Nigam Limited, Ajmer Vidyut Vitran Nigam Limited and Jodhpur Vidyut Vitran Nigam Limited by the State Government during the year 2008-09 to 2011-12 shall be reduced and charged at the rate of 0.5% on the market value of the land but stamp duty already paid shall not be refunded.
