Subject : Deferment of partial salary of March paid April, 2020 - looking at economic slowdown due to COVID-19 LOCKDOWN.


The Finance Department has issued Order No.F.1(4)FD/ GF&AR/ 2006 dated 31.3.2020 regarding deferment of partial salary of March paid April, 2020.

The point No. (iii) and (iv) of the above mentioned order are hereby substituted as under :-

- "(iii) There shall be a deferment of 50% (16 days) in the gross salary of March, 2020 in respect of all State and Subordinate Services officers/employees drawing their salary above L-9 of pay matrix (in other words 'L-10 and above').
- (iv) There shall be a deferment of 30% (9 days) in the gross salary of March, 2020 in respect of all other officers/employees (of any cadre/service/strength of Govt. of Rajasthan called by whichever name) drawing their salary from L-5 to L-9 of pay matrix.


Exception : The whole staff of Medical & Health and Medical Education Departments, Police Constables, Class-IV employees and all employees of Government drawing their salary in L-1 to L-4 of pay matrix shall be exempted from above salary deferment."


