ORDER

Sub:- Amendment in the AVVN Scheduled Areas Engineers, Ministerial and Class-IV Service (Recruitment and other Service Conditions) Regulations, 2017.

The Coordination Committee of Rajasthan State Power Sector Companies in its 23rd meeting held on 23.12.2019, decided as an inter-company coordination issue, to adopt notification no. F.2(1) DoP/ A-II/ 2014 dated 2.11.2015 and no. F.2(1) DoP/ A-II/ 2014 dated 23.02.2016 issued by Department of Personnel, GoR and accordingly to amend Vidyut Nigams' Scheduled Areas Engineers, Ministerial and Class-IV Service (Recruitment and other Service Conditions) Regulations, 2017.

Accordingly, following amendments are hereby made in the AVVN Scheduled Areas Engineers, Ministerial and Class-IV Service (Recruitment and other Service Conditions) Regulations, 2017; namely:-

(1) The existing Regulation 5 shall be substituted by the following:-

“ 5. Constitution of the service:- The Service shall consist of:-

- (a) all persons recruited to the post (s) included in the Service and remained in position in the Scheduled Area before commencement of these regulations and opted for the service as provided in sub-regulation (3) of regulation 6;
- (b) all persons transferred to the Scheduled Area from rest part of the state on the basis of options given by them, upto the date specified by Nigam; and
- (c) all persons recruited to the Service by any of the method of recruitment laid down in these regulations.”

(2) In Regulation 6, between the existing sub-regulation 3 and sub-regulation 4, the following new sub-regulation 3(a) shall be inserted :-


“ 3(a) Existing persons in position outside of the Scheduled Area of the State shall also have one time option for their absorption in the corresponding service in the Scheduled Area. The options so received shall be considered by the Committee, as to whether any such person shall be absorbed or not. The Committee, while considering the option, shall also ensure compliance of notification no. F. 13(20)DOP/A-II/91 Pt. dated 16.06.2013. The person so absorbed shall not have the right to be transferred and /or deputed again outside the Scheduled Area.”

(3) The existing Regulation 14 shall be substituted by the following:-

“ 14. Age- For direct recruitment to the post(s) included in the service, provisions relating to age specified in the relevant service regulations pertaining to such post(s) shall apply.”

This is subject to ratification by the Board of Directors of the Nigam.


